As part of NCSSD activity, one day technical seminar on "Awareness on Cyber Security" was organized in association with AIT at SVCE.

The programme started at 10 a.m with prayer song. The chief guest was introduced by Dr. T. Sukumar, AP/IT.

The HoD invited and addressed the gathering about the current trend automation and human to machine ratio in future 2022 would be 19:28 and 24:68 ratio in decision making and data processing field. She has provided an idea about ever growing technologies such as AI and ML and how its giving to replace human jobs.

The chief guest Mr. Raj, M/S, Cyber Raaj, Principal Consultant, pointed out the need of Cyber security to protect computer systems from theft/damage, including external and internal threats. Additionally, he provided the suitable suggestions to prevent systems from potential logical/physical damage. He also explained the evolution of Industrial revolution (current Industrial revolution version is 4).

He covered with Cyber security privacy concern, violation of resources, identity theft, copyright violation, reputation Protection and laws and regulations. He stressed ignorance of information sharing and lack of knowledge about the complications involved while accessing ta over an internet may result in the privacy issues and other Cyber threats. Subsequently, he explained IT Act 2000.

He created awareness about authority who are controlling and preserving in Cyber security field are such as ISO 27000, ISO 27001, British Standard 7799 part-3, COBIT (Control Object for Information Technology), ITIL (ISO 20000), PCI-DSS (Payment Card Industry and Data security Standard).

He suggested the students to equip in the Cyber security basic certifications courses such as CompTIA- Security, MTA Security, CCNA, GSEC,ITIL and Intermediate courses such as CEH,SSCP,CCNP,OSCP and advanced courses such as CISSP (ISC), CISA,CISM,ISO 27001,ITA Certification (Institute of Internal Audit)

He covered the top rated jobs for the students in the areas such as Data Analysis, Computer Programming/Developers/Security Analysis, Architecture and Engineering, Bio chemical, Nano, Robotics, Specialized sales and Transformation Roles.


He mentioned the top 5 areas of AI (Artificial Intelligence) which causes 5 Million Jobs loss expected in 2020 which in turn affects job of Telemarketers, Clerks – Book keeping, Compensation and Benefit managers, Receptionists and Couriers.

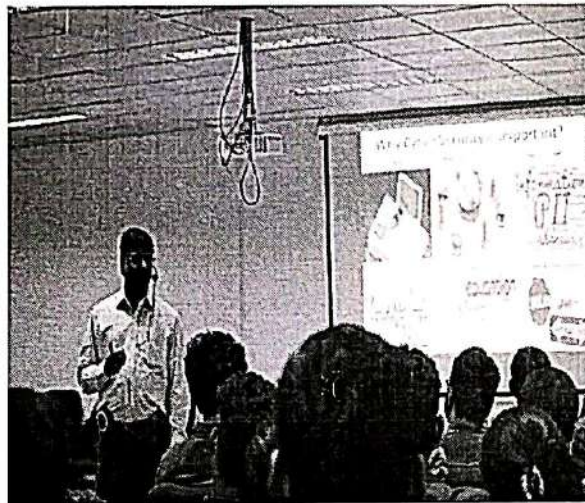


