- 4. The programs have been granted accreditation for 3 years. Sri Venkateswara College of Engineering, Post Box No.: 3, Chennai Bangalore Highway, Pennalure, Kancheepuram District, Tamil Nadu- 602 105 should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
